- Additional comparative modeling data provided for various wall heights (i.e., 7ft, 12ft, 15ft, and 20ft).
- Material samples and color options provided.
- Joint walk of buffer area scheduled for 9/8/22.
- Landscape Architect has been onboarded.

- Condition 19: Share and Consult.
- Condition 20: FPA Filing Requirement.
- Condition 21: Sound Wall and Reeves Field Only.
- Condition 22: Trees and Buffer Area.
- Condition 24: Amplified Noise Sources.
- Conditions 25-39: Controls for Usage, Monitoring, Scheduling, Reporting, and Other.
- Condition 40: General Compliance.



- Condition 19: Share and Consult.
 - Design shared.
 - Modeling shared.
 - Narratives shared.
 - Sound measurement data shared.
 - Access provided.
 - Joint consultation has occurred.



Condition 20: FPA Filing Requirement.

• Filing of the FPA is planned for 9/14/22.



Condition 21: Sound Wall and Reeves Field Only.

 Only the Jacobs Field Sound Wall and the Reeves Scoreboard Replacement will be included in the FPA on 9/14/22.



Condition 22: Trees and Buffer Area.

- Design and placement of wall minimizes damage.
- Design includes commitment to 1:1 replacement for trees lost and protection requirements for trees to remain.



Condition 24: Amplified Noise Sources.

- Air horns will not be used.
- System settings jointly determined.
- Speaker placement jointly determined.
- Limiter activated.



- Conditions 25-39: Controls for Usage, Monitoring, Scheduling, Reporting, and Other.
 - No night use.
 - Frequency and types of events.
 - Coordination and Communication.
 - Monitoring of amplified noise.
 - Fence and Buffer Area Continued.



- Condition 40: General Compliance.
 - Comply with all conditions and remain in compliance.
