AMERICAN UNIVERSITY'S CAMPUS PLAN HONORING COMMITMENTS

Following approval of the last campus plan (August 2001), American University has worked to honor commitments and build an ongoing rapport with the surrounding neighborhoods through a variety of means. The objective has been to improve the familiarity between community members and various offices and individuals at American University who can assist with needs ranging from information requests to problem solving.

AU's efforts have included:

- Meetings (liaison committee and other) -- to focus on both specific and general issues;
- Office of Community Relations -- created as a key contact and coordinating point;
- Community relations Web site (www.american.edu/communityrelations) -- with updates and helpful information accessible 24/7;
- Monthly e-newsletter (A U in the Neighborhood) -- with campus news and information of neighborhood interest;
- Phone numbers and contact information -- distributed via brochures and refrigerator magnets;
- Online form -- for ease of filing complaints or incident reports;
- Personal representation/attendance at community fairs and events -- to answer questions and raise awareness;
- Postings on neighborhood list serves -- to clarify and update university positions;
- Annual December reception for community members -- as a social/non-business occasion.

<u>Liaison Committee Meetings</u> -- have been a valuable part of this rapport and a regular opportunity for community members and university officials to gather to compare notes and discuss issues both general and specific. Typical agenda items include, for example, an update on facilities, maintenance and building projects; student issues; parking enforcement; Army Corps of Engineer updates; university calendar or events of note; and other issues that might affect the surrounding neighborhoods or raise questions or concerns.

University offices regularly represented at liaison meetings and available for presentations, questions, or elaboration include: Campus Life/Dean of Students; Facilities and Administrative Services; Public Safety; Law School Facilities; Community Relations; President's Office; Transportation Services; and AU Counsel.

Past meetings have included representation from specific neighborhoods and community organizations including AU Park; Spring Valley; Wesley Heights; Tenley Campus; Fort Gaines; Westover Place; Embassy Park; Neighbors for a Livable Community; Spring Valley Court; ANC-3E; and ANC-3D.

2009 - 2010

Generally, the university will take disciplinary action for on-campus infractions of the Code. However, the university may take disciplinary action for off-campus infractions of the Code when a student's behavior threatens or endangers the safety and well-being of the campus community. The university may take action against a student who is the subject of a violation of local, state, or federal law.

2010 - 2011

Generally, the university will take disciplinary action for on-campus infractions of the Code. However, the university may take disciplinary action for off-campus infractions of the Code when a student's behavior threatens or endangers the safety and well-being of the campus community; when a student is the subject of a violation of local, state, or federal law; or when, in the judgment of university officials, a student's alleged misconduct has a negative effect on the university's pursuit of its mission or on the well being of the greater community. 
