Professors Paul Gugliuzza and Jason Rantanen will present their research, co-authored by Professor Jonathan Remy Nash, into a robust dataset of the Federal Circuit's decisions and dissents. In conversation with Professor Megan La Belle and Seth Lloyd, the panel will explore the decision to dissent and the power of a dissent.

PANEL

Moderator: Krista Trefren, AULR Senior Staffer, LT, U.S. Navy

Topic: This panel will explore *Bufkin v. McDonough* and the benefit of the doubt rule at the heart of the case's appeal to the Supreme Court. 38 U.S.C. § 5107(b) states that the Secretary of Veterans Affairs "shall give the benefit of the doubt to the claimant" when there is "an approximate balance of positive and negative evidence" that is material to deciding a matter. The Supreme Court's decision has the potential to expand benefits for thousands of veterans who have suffered traumas in connection with their service. *Bufkin v. McDonough* is set for oral argument before the Supreme Court on October 16, 2024.

TRADEMARK LAW

PANEL

Moderator: Professor Christine Haight Farley

Topic: The Federal Circuit decided Bureau National Interprofessionnel du Cognac v. Cologne & Cognac Entertainment on August 6, 2024. Cologne & Cognac Entertainment, a hip-hop record label, registered for the mark "Cologne & Cognac Entertainment" to use in connection with music composition services, live entertainment, CDs, digital downloads, and other related uses. The Bureau National Interprofessionnel du Cognac and the Institut National des Appellations d'Origine are entities responsible for controlling and protecting the certification mark "Cognac," and they opposed Cologne & Cognac Entertainment's application. The Trademark Trial and Appeal Board dismissed the opposition, holding that the mark was not likely to cause confusion or dilution, but the Federal Circuit vacated and remanded the decision. This panel will discuss the Federal Circuit's decision, consumer confusion, trademark dilution, and the unique aspects of geographical marks in trademark law.
